- C. From May 1975 to May 1978, McNicol served as a Chairman of the Program of Biblical Studies of the Bible Chairs at the University of Texas and participated on the relevant standing University Committees attendant to that position. He held that position again from 1984 to 1987.

- D. In 1981-1983, McNicol was elected Vice-President and President respectively of the Society of Biblical Literature Southwest Region. From 1981-1984, he served as a director of the Southwest Commission on Religious Studies.
- E. From August 1982 until April 1984, upon invitation of Professor W. R. Farmer, Perkins School of Theology, SMU, McNicol became a regular participant in Farmer's research project of the Synoptic Problem. This seminar operated under the auspices of the International Institute for the Renewal of Gospel Studies. The research group met in Dallas each month during this period. As a member of this research group, McNicol was a participant in the *Symposium de interrelatione evangeliorum, pascha*, Jerusalem in 1984, and his paper, "The Composition of the Synoptic Eschatological Discourse Based on an Original Synopsis," was later published in the volume of the proceedings of that meeting. Since that period he has participated in numerous symposia and meetings sponsored by this Research Group that continue until the present time. This includes being an invited participant to an International Symposium at the University of Göttingen on the issue of "Die Minor Agreements" in 1991. Upon the retirement of William Farmer in 1992, McNicol has continued to work with this research group on the Synoptic Gospels. Two major books, *Beyond the Q Impasse: Luke's Use of Matthew*, 1996, and *One Gospel from Two: Mark's Use of Matthew and Luke*, 2002, have come from this research.
- F. From 1987-2012, McNicol taught a regular sequence of courses at Austin Graduate School of Theology in New Testament, Biblical Theology, and Christian Worship.
- G. In 1992, McNicol was appointed as the holder of the A. B. Cox Chair of New Testament at Austin Graduate School of Theology.
- H. In the Spring of 1993, as a result of a grant from the Biblical Studies Center, an International Symposium on Isaiah and the Dead Sea Scrolls was sponsored by the College of Liberal Arts, University of Texas at Austin. McNicol served as co-chairman and joint organizer of the Symposium.
- I. In 1993, McNicol was appointed to the Editorial Board of the scholarly journal, *Restoration Quarterly*.
- J. In the spring semesters from 1996-1999 McNicol was appointed Visiting Lecturer in Classics at the University of Texas at Austin and taught Reading Courses in the Greek New Testament on the Gospels, Paul, and Apocalyptic Literature.
- K. In 1998, McNicol was elected as a member of *Studiorum Novi Testamenti Societas*, the international community of New Testament Scholars.
- L. In the spring of 2002 and 2004, McNicol taught courses as a visiting professor, Institute for Biblical Studies, Zagreb, Croatia.
- M. In the summer of 2005, McNicol was named as an adjunct/faculty member of the Institute for Theology and Christian Ministry in St. Petersburg. In July 2005, he taught a course on-site on Apocalyptic Literature, and in January 2006, he taught a course on Biblical Theology and gave a University lecture on "Revelation: An Overview."
- N. In 2008, McNicol began to serve on the Coordinating Committee for the Greater Austin Stone-Campbell Dialogue. He delivered two papers at the first annual symposium of the group in Austin (July 2008).
